County Wexford Farmers Markets Code of Practice

1. THE HOURS OF OPERATION ARE FROM 9am TO 2pm EACH SATURDAY (FRIDAY FOR WEXFORD TOWN)

- a. The hours may be changed by a vote by the group
- b. A minimum of two weeks' notice is required
- c. The public must be notified of all changes in the local media

2. STALL SET UP AND REMOVAL

- d. Stalls must be set up by 9am and vans clear of public area
- e. Stall and equipment not to be removed until after 2pm
- f. Stalls must be manned during this time

3. SITE SANITATION

- g. Stall holders are responsible for keeping the area in and around their stalls clean at all times
- h. Stall holders shall provide a rubbish bin for the use of the public
- i. Stall holders are collectively responsible for keeping the market site clean and litter free at all times

4. PRODUCE TO BE SOLD AT THE MARKET

- j. Produce sold at the market should be produced and sold directly from farms in County Wexford
- k. If a producer comers from outside the county a full meeting of the market must be held to vote on access for the product
- I. Exotic products may be bought in from outside the area
- m. Seasonal stall holders must inform the market controller of the number of months they are to trade at the market. Three weeks' notice is to be given to the controller of them leaving the market.

5. STANDS AND CANOPIES

- n. The preference of the market group is the Caravan canopy in white as seen in the market
- o. All other canopies to be vetted by the market controller
- p. On the day the controller has the decision
